

**Interinstitutional Programme of Graduate Studies “Logic”**  
**Registration process**  
**Academic year 2025–26**

All applicants who have been accepted to attend the Interinstitutional Programme of Graduate Studies “Logic” are kindly requested to submit the following documents:

- Registration Form (attached)
- University Graduate Degree BA/BSc or Graduation Certificate.
- A transcript of records.

Degrees and transcripts issued by foreign universities should be officially apostilled/certified. The authenticity of degrees from foreign institutions can be verified through one of the following methods:

- a. APOSTILLE stamp for countries that have ratified the Hague Convention;
- b. certification from the local Greek Consular Authorities for countries that are not part of the Hague Convention;
- c. verification via a link that allows confirmation of the authenticity of the title by the issuing authority;
- d. electronic confirmation of authenticity using a QR CODE issued by the degree-awarding institution.

Greek students who have studied abroad do not need to have their degree and transcript apostilled or certified but should submit a certificate of recognition from DOATAP.

- Passport which will be valid for at least three months from the date of registration or national ID card that allows one to travel in the European Union. If the place of birth is not explicitly indicated, the student will need to present a certified/apostilled birth certificate.
- Health Insurance (Greek students do not need to provide that, and students who come from other member states of the EU can submit the European insurance card).
- One (1) small size photograph (passport type). Students are advised to have the passport and the photo in digital form (scanned).
- Students from non-EU countries should have already obtained a Type D1.1 visa for Studies and provide it to the Registrar's office.
- Certificate of competency in English (not required for native speakers)
- Bank receipt for tuition fees (1st instalment).

**Greek incoming students only** will submit all of the above documents online at the link: <https://eprotocol.uoa.gr/> by selecting the field: «06. Υποβολή Δικαιολογητικών Εγγραφής Μεταπτυχιακών Φοιτητών - Υποψηφίων Διδασκτόρων» .

**The above process is mandatory in order for students to complete their registration and be granted access codes to the University’s services.**

**Registration period:**

Postgraduate students who are entitled to exemption from payment of tuition fees based on article 86 of Law 4957/2022 will submit their request online to the link:
